

DECLARATION OF INCORPORATION OF PARTLY COMPLETED MACHINERY IN ACCORDANCE WITH EC MACHINERY DIRECTIVE 2006/42 EC

Société Internationale des Moteurs Baudouin – Technoparc du Brégadan – 13711 Cassis Cedex – France, declares that 4-cycle diesel engines referenced below are manufactured as Partly completed machinery in accordance with Machinery directive 2006/42/EC.

Fundamental health and safety requirements applied to, and fulfilled by, the below-mentioned engines are described in the following items in Annex I; 1.6.1, 1.6.2, 1.6.4, 1.7.1, 1.7.1.1, 1.7.1.2, 1.7.4, 1.7.4.1, 1.7.4.3. The relevant technical documentation is compiled as described in part B of Annex VII. Relevant information concerning the partially-completed machinery will be provided in suitable form upon justified requests from competent national authorities. The individual authorized to compile the relevant technical documentation is the signer of this declaration.

The below-mentioned engines shall not be put into service in the European Community until the final machinery into which it is to be incorporated has been declared in conformity with the provisions of Directive 2006/42/EC and all other applicable EC Directives.

The below-mentioned engines are not intended to be used in non-road mobile machinery applications within the European Union.

The Société Internationale des Moteurs Baudouin engines are, as stated in the declaration, supplied as a component and must not be operated until installed and equipped with proper covers and protection for the drive belts, fan, couplings, hot and rotating parts etc. in accordance with EC Machinery directive 2006/42 EC. The below-mentioned engines have moving parts and parts at high temperatures which contains fluids under pressure, have an electrical system which may be under high current, produce harmful exhaust gases, noise and vibrations. The installer shall therefore take suitable precautionary measures when moving, installing and operating the engines to reduce the risks connected with the characteristics listed below. The engines must be used according to the scope of supply and must be installed in accordance with the assembly and use instructions and with the local regulations.

The Société Internationale des Moteurs Baudouin engines are also compliant with the following relevant Directive :

- 2014/30/EU, directive concerning electromagnetic compatibility
- 2011/65/EU, directive concerning the restriction of use of certain hazardous substances
- 2015/863/EU, commission delegated directive amending Annex II to Directive 2011/65/EU of the European Parliament and of the Council as regards the list of restricted substances
